- II. To promote such other objects not inconsistent with the spirit of the Trust inferred from the above, the Trustees may add to the above mentioned objects having regard to the particular needs of the time, provided that the application of the Trust's funds shall be done without any discrimination based on nationality religion, class or sex. Provided this clause does not envisage expansion of the objects of the Trust or inclusion of any other object or objects which are inconsistent with or repugnant to the provisions of Section 2(15), 11, 12, 13 and 80 G of the Income-tax Act, 1961 or any other relevant provisions of the Income-Tax Act.
- III. The Board of Trustees may grant such stipends and scholarships, on such terms as they may deem fit as may be commensurate with the income of the trust property. The funds and the income of the Trust shall not be utilized for payment to the Trustees by way of profit, interest, dividend, etc.

D. THE BOARD OF TRUSTEES

1. There shall be a Board of Trustees consisting of all the Trustees. The total number of Trustees at any given point of time shall be minimum three Trustees and not more than twelve Trustees.
2. The aforesaid Trustees shall be Trustees for life. The Trustees can co-opt, with mutual consent, any other person or persons, as Trustees. The Trustees so co-opted shall hold office as Trustees for a period of two years.

3. The members of the Board of Trustees shall be indemnified against all expenses and losses incurred or suffered or any payments made by them in the administration of the Trust and such expenses, losses and payments shall be borne by the Trust and none of the Trustees shall in any way be personally liable or responsible for the same.
4. A Trustees may be held liable only for such moneys or securities as they shall actually receive and shall be answerable and accountable for their own acts, receipts, neglect or default and not for those of the other nor for any banker, broker, auctioneer or other person with whom or into whose hands any Trust moneys or securities may be dispatched or come up for insufficiency in title or deficiency in value of any investment or for any other loss unless the same shall happen through his own wilful act or default.

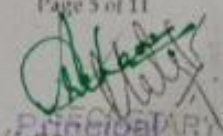
E. THE POWERS OF THE BOARD OF TRUSTEES

With a view to carrying out the objects of the Trust hereinabove mentioned and to augment its funds and administer them and in discharge of their duties, the Trustees shall be entitled to frame such guidelines and rules as may be required from time to time and shall have the following powers:

1. The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any

2. To invest the funds from time to time in such manner as may be deemed fit, from time to time and to realise the investments, to acquire or sell properties and securities. Provided, however, that the same is approved by at least 2/3rd of the Trustees present at a meeting of the Board of Trustees duly convened and subject to the condition that the funds of the Trust shall be invested in the modes specified under the provisions of Section 13(1) (d) read with Section 11(5) of the Income Tax Act, 1961 as amended from time to time.
3. The funds and the income of the Trust shall be used and applied only for the purpose of achieving the main objects of the Trust and no portion of the same shall be utilised for payment to any Trustee by way of profit or interest. Provided, however, that the funds and incomes may also be utilised for achieving the other/ancillary objects with the prior approval of the Board of Trustees.
4. To open and maintain bank accounts in any bank(s) and operate them and to collect interest, dividends, other income from bank accounts and other investments.
5. To represent the Trust in all courts or statutory authorities or government, semi-government, and local bodies, in all matters for which such representation is required. Delegate any of the powers of representation and action to any member of the board of Trustees, and revoke, vary or rescind such powers as necessary, in the matter of signing and verifying all pleadings, memorandum of appeal, petitions and applications or in

6. To meet all necessary expenses incurred or to be incurred in connection with the administration of the Trust.
7. To borrow for the purpose of the Trust on the credit of the Trust with or without charge and responsibility upon, provided, however, such powers shall be exercised by the Trustees only with the prior written approval of the Trust and only in the event it is passed by at least 2/3rd of the Trustees present at a meeting of the Board of Trustees duly convened and having the prescribed quorum.
8. To appoint an Executive Committee of the Trust from among the Trustees and assign duties and seek suggestion(s) for the purpose for the working of the Trust.
9. To apply and use the funds for all or any of the main objects of the Trust or for promoting furthering, or achieving the main objects of the Trust.
10. To pay out of the Trust funds, salaries, wages, rent, building maintenance, repairs and other expenses relating to the Trust and its activities or its other affairs.
11. The Board of Trustees, from time to time may frame rules for the conduct and regulation of overall management of the Trust and the Educational Institutions managed by the Trust.

12. To undertake and carry on any other work which may seem to the Trustees capable of being conveniently carried on in connection with an existing activity or calculated directly or indirectly for the promotion of the Trust.
13. The Managing Trustee or Trustees shall have power to enter into agreement/s which are necessary to attain the objects of the Trust, subject to passing of resolution in the meeting of the Trustees or by circulation and accepted by a majority of the members present in the meeting.
14. Any Trustee may call for convening of a meeting of the Trustees by sending a written request to the Managing Trustee, setting out there in the matters to be discussed. The meeting shall be called within fifteen days from the receipt of the request, setting out the date, time, place, and draft agenda giving at least seven clear days of the written notice for the meeting.
15. The quorum for the purpose of meeting of the Board of Trustees shall be 2/3rd Trustees present and voting in said meeting.
16. The Trustees shall not function or carry on any activity which may be incongruent or prejudicial to the interests of the trust.
17. To apply and use the funds for all or any of the objects of the Trust or for promoting, furthering or achieving the objects of the Trust.

F. CHAIRMAN AND MANAGING TRUSTEE

The Chairman of the Trust shall be the Managing Trustee of the Trust. The Managing Trustee being one of the Trustee shall act as the Chairman at the

G. EMERGENCY POWERS OF THE CHAIRMAN OF THE BOARD OF TRUSTEES

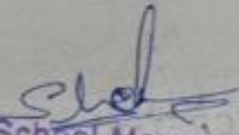

H. ACCOUNTS

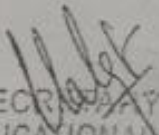
The final accounts of the Trust shall be closed at the end of every financial year i.e. 31st March of every year. The accounts of the trust shall be maintained regularly and shall be duly audited by a qualified Chartered Accountant. All the statements of account shall be counter-signed by at least two Trustees including the Managing Trustee.

I. AMENDMENT TO THE TRUST DEED

The Trust Deed shall be amended by 2/3rd majority of the Trustees in the meeting specifically called for the purpose and the resolution passed by such majority as circulated with or without notification shall be final and binding on this deed. Further, no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.

J. DISSOLUTION OF THE TRUST

This trust may be dissolved at any time by passing such requisite resolution with 2/3rd majority of all the Trustees. The Trust shall be dissolved if all the persons holding the office vacate the office as Trustees for any reason and no other person is appointed and upon dissolution, the provision of the clause above of this instrument shall apply. Upon dissolution of the Trust, the entire Trust property shall be realised and first be used for payment of liabilities of the Trust and for meeting expenses of realisation. 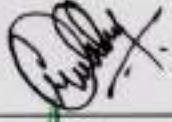

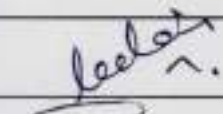

Both Founder Trustees shall commit any act or breach of Trust of the Trust fund or property or cause any loss to the Trust property or commit fraud in the administration of the Trust fund / property.

The Founder Trustees shall hold honorary office and shall not be entitled to any Salary, allowances or perquisites, except for the reimbursement of actual expenses incurred in connection with attending to the Trust matters.

B. ROLES AND RESPONSIBILITIES AND POWERS

The Roles, Responsibilities and powers of both the Founder Trustees are equal.

a) PRESIDENT /CHAIRMAN /SETTLOR/ MANAGING TRUSTEE

In addition to discharging normal duties of a Founder Trustees, the President/Chairman/Settlor/Managing Trustee shall preside over meeting of the appointed Trustees. The Founder Trustees are authorized to sign all documents, including Bank documents, acknowledged for the contributions received and agreements with individuals, Government Institutions and other organizations, along with other Founder Trustees. President/Chairman/Settlor/Managing Trustee's decision is not final, unless both Founder Trustees give written consent and then take necessary decision.

The Founder Trustees are authorized to sign bank cheques, deposit release vouchers etc. The Founder Trustees are empowered to remove any member from the Trust and its offices, if he/she finds that his/her activities are not congenial to the activities of the Trust.

The Founder Trustees are responsible for ensuring that the Trust pursues its Objects and for maintaining the dignity of the Trust organization and shall use his influence to promote the activities of the Trust.

The Treasurer will prepare Annual Budget, monthly and yearly expenditure statements get the expenditure audited by auditor duly appointed by the Founder Trustees for their approval. The Treasurer is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgement for the amounts or articles received by the Trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the Trust and place them before the Founder Trustees for their approval.

The Treasurers will sign applications for drafts and payment instructions jointly with the Founder Trustee. The Treasurer is responsible for safe custody of cash, bonds, securities etc. of the Trust.

IX. ACCOUNTS AND AUDIT:

The financial year of the Trust shall be from 1st April to 31st March of the following year, unless otherwise decided by the Founder Trustees.

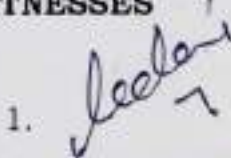

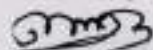

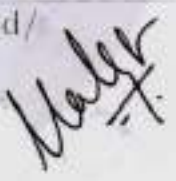
